

Case #2015-002 Respondent: Zhaohui D. Quin/Lotus Massage and/or Alabama Chinese Acupressure License #: E-2330

Date: April 15, 2015

Allegation: Zhaohui D. Quin, d/b/a Lotus Massage and/or Alabama Chinese Acupressure violated Ala. Code §§34-43-11 and 34-43-15(a)(5)(8) by advertising under an establishment name for which he did not have a license.

Board Action: Zhaohui D. Quin entered into a Consent Order with this Board regarding the alleged violations. Pursuant to said consent order, Mr. Quin was fined \$500.00. The fine has been paid in full.

Case #2015-004 Respondent: Qun Li/Panda Acupressure License #: 4160

Date: April 10, 2015.

Allegation: Qun Li violated Ala. Code § 34-43-11, for not having an establishment license.

Board Action: Qun Li entered into a Consent Order with this Board regarding the alleged violations. Pursuant to said consent order, Mr. Li was fined \$500. The fine has been paid in full.

Case #2015-014 Respondent: Hui Jun Liu/June Massage License #3857

Date: April 10, 2015.

Allegation: Hui Jun Liu violated Ala. Code § 34-43-11, for not having an establishment license.

Board Action: Hui Jun Liu entered into a Consent Order with this Board regarding the alleged violations. Pursuant to said consent order, Ms. Liu was fined \$500. The fine has been paid in full.

Case #2015-003 Respondent: Raymond Ward License #3683

Date: April 10, 2015.

Allegation: Raymond Ward violated Ala. Code §34-43-15(a)(3) and Alabama Board of Massage Therapy Administrative Code Rule 532-x-5-x-.03(1)(d), by engaging in unprofessional conduct.

Board Action: Raymond Ward entered into a Consent Order with this Board regarding the alleged violations and agreed to immediately surrender his Massage therapy license and not reapply for licensure in the State of Alabama for a minimum of three (3) years.

Case #2015-005 Respondent: Qun Li, d/b/a QQ Acupressure License #: 4160

March 27, 2015

Allegation: Qun Li, d/b/a QQ Acupressure violated Ala. Code §§34-43-11 and 34-43-15(a)(5)(8) by advertising under an establishment name for which he did not have a license.

Board Action: Qun Li entered into a Consent Order with this Board regarding the alleged violations. Pursuant to said consent order, Mr. Qun was fined \$500.00. The fine has been paid in full.

Case #2015-013 Unique Spa/Ronnie Song License #: E-2094

March 27, 2015

Allegation: Ronnie Song, as owner of Unique Spa, violated Ala. Code §§ 34-43-8(b) and 34-43-15(a)(3) & (5) and Alabama Board of Massage Therapy Administrative Code Rule 532-x-5-x-.03(1)(d) for promoting prostitution and unprofessional conduct.

Board Action: Massage Therapy Establishment license has been surrendered.

Case #2015-013 Ronnie Song License #: 3433

March 27, 2015

Allegation: Ronnie Song, as owner of Unique Spa, violated Ala. Code §§ 34-43-8(b) and 34-43-15(a)(3) & (5) and Alabama Board of Massage Therapy Administrative Code Rule 532-x-5-x-.03(1)(d) for promoting prostitution and unprofessional conduct.

Board Action: Massage Therapy license has been surrendered.

Case #2016-001 Respondent: Sun Ae Yi/Rainbow Sauna License#: E-2297

Date: March 25, 2015 & Massage

Allegation: Sun Ae Yi, owner of Rainbow Sauna and Massage, violated Ala. Code §§34-43-11(a) and 34-43-15(a)(3), 34-43-15(c) and Alabama Board of Massage Therapy Administrative Code Rule 532-X-5-.03(1)(d) for promoting prostitution.

Board Action: Sun Ae Yi entered into a Consent Order with this Board regarding the alleged violations.

Pursuant to said consent order, Mr. Yi's Massage Therapy Establishment License has been surrendered and he shall not reapply for licensure in the State of Alabama for a minimum of three (3) years.

Case #2015-001 Respondent: Pok N. DeGuzman License#: 2261

Date: March 25, 2015

Allegation: Pok N. DeGuzman violated Ala. Code §§34-43-8(b) and 34-43-15(a)(3) & (5) and Alabam Board of Massage Therapy Admininstrative Code Rule 532-X-5-.03(1)(d) for promoting prostitution.

Board Action: Pok N. De Guzman entered into a Consent Order with this Board regarding the alleged

violations. Pursuant to said consent order, Mr. DeGuzman's Massage Therapy License has been surrendered and he may not reapply for licensure in the State of Alabama for a minimum of three (3) years.
