By having staff guidelines, the Board can provide a more equitable treatment of similarly situated applicants and licensees. Board guidelines were initially approved in June 2024. Following a summer of working with the open cases, these guidelines have been revised to be streamlined, and to separate them out into one guideline for individuals and another guideline for entablements.

On September 20, 2024, Ms. Seip moved that the Board approve the revised guidelines for disposition of cases. Ms. Buford seconded. Motion carried without objection.

VIII. POLICY

A. FINAL CERTIFICATION AND EMERGENCY RULES - REPEAL AND REPLACE ALABAMA MASSAGE THERAPY LICENSING BOARD ADMINSTRATIVE CODE 532-X-1, 532-X-2, 532-X-3, 532-X-4, 532-X-5, 532-X-6, 532-X-7, 532-X-8, 532-X-9.

Mr. Ingels reported that effective June 1, 2024, Alabama Act No. 2023-361 dissolved the Alabama Board of Massage Therapy (ABMT) and reconstituted it as the Alabama Massage Therapy Licensing Board (AMTLB) placing the AMTLB under the management of the ABN Executive Officer and designated staff through September 2026. The Act further establishes the ABN Board as the governing board of the AMTLB, pending appointment of the members of the AMTLB. ABN staff propose promulgation of a new Alabama Massage Therapy Licensing Board Administrative Code in nine chapters, to facilitate the new ministerial arrangement and to implement substantive changes established in the new statute.

At the June meeting, the Board approved certification of the nine chapters as emergency rules, which expire October 19. Unforseen issues implementing the rules as proposed and emergency certified, necessitate recertification as emergency rules, which will be superseded by the permanent rules when those rules take effect in November 2024.

As rules necessary to implement state statute duly passed by the Alabama Legislature and signed by Governor Ivey, these proposals are expected from the moratorium on rule promulgation established by Executive Order 735.

On September 20, 2024, Ms. Armstrong moved that the Board approve as final certification and emergency rules, Alabama

Massage Therapy Licensing Board Administrative Code Chapters 532-X-1, 2, 3, 4, 5, 6, 7, 8, and 9. Dr. O'Keefe seconded. Motion carried without objection.
