3. LOTTERY DRAWING OF TERM LIMITS

Ms. Benson reported that the Board is required by regulation to draw by lottery term limits for the newly reconstituted AMTLB as outline below:

c) Of the initial nine appointees to the board.

- Three members shall be appointed for terms of two years.
- Three members shall be appointed for terms of three years.
- Three members shall be appointed for terms of four years as determined by lottery.

Thereafter, successors shall be appointed for terms for four years, each term expiring on June 30.

By draw by lottery Mr. Boone, Mr. Henderson, Jr., and Ms. White will serve a term of four years, Ms. Cooper, Ms. Long, and Ms. Gillis will serve a term of three years and Mr. Arainrad, Ms. Morris and Ms. Ranger will serve a term of two years as Board members on the AMTLB Board.

In no event will this period of suspension extend beyond twelve (12) months of the effective date of this Order.
